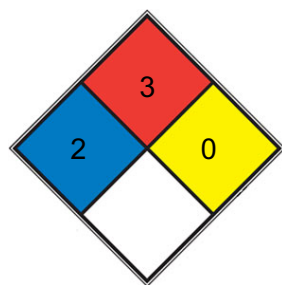

### Eye/face protection
