### Personal precautions, protective equipment and emergency procedures

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

### **Bioaccumulative potential**

Based upon a water solubility of 22 ppm at 26 degC(1), a BCF of 108 has been estimated(2). Based upon this estimated BCF, chlorazine will not be expected to bioconcentrate in aquatic organisms(SRC).

### **Mobility in soil**

Adsorption of triazines through an exchange process to organic matter & clay minerals is dependent on the pH of the soln & the acidity of the adsorbent surface. Hydrogen bonding & hydrophobic bonding are other mechanisms by which soil organic matter adsorbs triazine herbicides, especially at higher pH levels. ... Transport from soil to water occurs in soln & in sediments. Triazine herbicides

### **Disposal methods**

#### **Product**

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### **Contaminated packaging**

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
