SECTION 4: First aid measures

Description of first aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Rinse with pure water for at least 15 minutes. Consult a doctor.

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

SYMPTOMS: Exposure to this chemical can cause irritation. ACUTE/CHRONIC HAZARDS: When heated to decomposition this compound emits toxic fumes of carbon monoxide, carbon dioxide and NOx. This chemical is harmful by inhalation, ingestion, or skin absorption. (NTP, 1992)



Personal precautions, protective equipment and emergency procedures

Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

Environmental precautions

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

Methods and materials for containment and cleaning up

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

Precautions for safe handling

Handling in a well ventilated place. Wear suitable protective clothing. Avoid contact with skin and eyes. Avoid formation of dust and aerosols. Use non-sparking tools. Prevent fire caused by electrostatic discharge steam.

Persistence and degradability

AEROBIC: 5-Nitrobenzimidazole, present at 100 mg/l, reached 0% of its theoretical BOD in 6 weeks using an activated sludge inoculum at 30

mg/l and the Japanese MITI test(1).

Bioaccumulative potential

BCFs of 0.7-1.8 were measured for 5-nitrobenzimidazole(1). According to a classification scheme(2), this BCF suggests the potential for

bioconcentration in aquatic organisms is low.

Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc for 5-nitrobenzimidazole can be estimated to be

120(SRC). According to a classification scheme(2), this estimated Koc value suggests that 5-nitrobenzimidazole is expected to have high

mobility in soil. 5-Nitrobenzimidazole is predicted(3) to have two environmentally relevant pKa's, one at 3.7 and the other at 10.7,

corresponding to the protonation and deprotonation of one of the nitrogens in the imidazole structure, respectively. Therefore, under neutral

environmental conditions, 5-nitrobenzimidazole will exist in the uncharged form. At low pH, some 5-nitrobenzimidazole will be cationic, and in

this form will be more likely to sorptive to soil particles.

Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do

not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to
