#### If inhaled

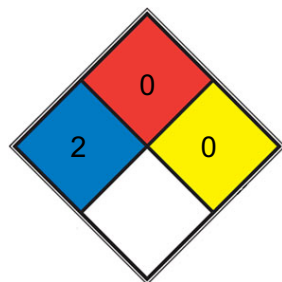

## SECTION 6: Accidental release measures

### Personal precautions, protective equipment and emergency procedures
