### Description of first aid measures

#### If inhaled

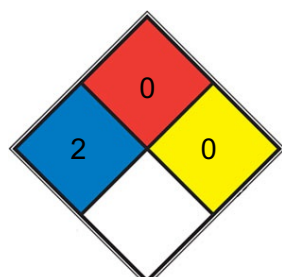

### Personal precautions, protective equipment and emergency procedures

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

Decamethonium dibromide is a quaternary ammonium salt used as a neuromuscular blocking agent. Quaternary ammonium salts often serve as catalysts in reactions. They are incompatible with many strong oxidizers and reducing agents, such as metal hydrides, alkali/active metals, and organometallics. Unlike the ammonium ion,  $[\text{NH}_4]^+$ , and the primary, secondary, or tertiary ammonium cations, the quaternary ammonium cations are permanently charged, independent of the pH of their solution.

#### **Product**

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning.
