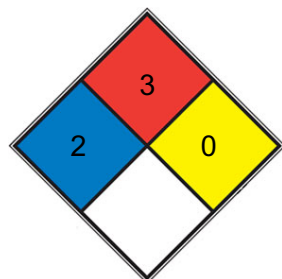

## SECTION 6: Accidental release measures

## **Personal precautions, protective equipment and emergency procedures**
