## SECTION 4: First aid measures

### Description of first aid measures

**If inhaled**

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

**Following skin contact**

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

**Following eye contact**

Rinse with pure water for at least 15 minutes. Consult a doctor.

**Following ingestion**

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

**Most important symptoms and effects, both acute and delayed**

SYMPTOMS: Symptoms of exposure to this compound via ingestion include emaciation, hypocalcemia, uterine disease, testicular atrophy and reproductive effects. It is irritating to tissues. ACUTE/CHRONIC HAZARDS: This compound is an irritant. There is clear evidence that it is an animal carcinogen. (NTP, 1992)

**Indication of any immediate medical attention and special treatment needed****Absorption, Distribution and Excretion**

When (14)c-labeled zearalenone admin by gavage to white leghorn laying hens, 94% of admin (14)c was eliminated via excreta within 72 hr. no major retention sites of (14)c activity were found, but persistent levels of lipophilic metabolites were detected in egg yolk.

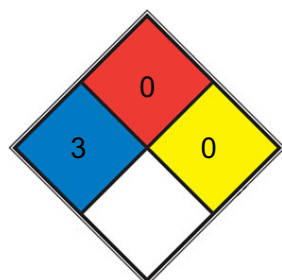

## SECTION 6: Accidental release measures

### Personal precautions, protective equipment and emergency procedures

ZEARALENONE is an ester. Esters react with acids to liberate heat along with alcohols and acids. Strong oxidizing acids may cause a vigorous reaction that is sufficiently exothermic to ignite the reaction products. Heat is also generated by the interaction of esters with caustic solutions. Flammable hydrogen is generated by mixing esters with alkali metals and hydrides. This chemical may be incompatible with alkalis.
