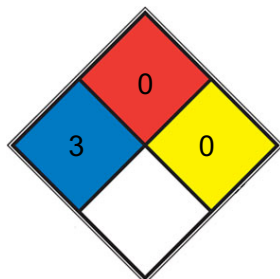

Aqueous solution is highly corrosive. Contact with acids reacts to form hydrogen fluoride, which is a highly corrosive and forms a toxic gas. Corrosive to aluminum. Incompatible with oxidizers; contact may cause fires or explosions. Keep away from alkaline materials, strong bases, strong acids, oxoacids, epoxides. Ammonium fluorosilicate reacts with water to form hydrofluoric acid, a source of fluoride ions.
