### **Description of first aid measures**

#### **If inhaled**

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately.

## SECTION 6: Accidental release measures

### Personal precautions, protective equipment and emergency procedures

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

### Environmental precautions

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

### Methods and materials for containment and cleaning up

### **Toxicity**

### **Persistence and degradability**

Based on extensive biological and chemical studies, the disappearance of fenuron from soil is due primarily to microbial degradation; however, no quantitative data were given(1). In a pure culture study, fenuron was degraded 10% by the soil fungus *Rhizoctonia solani* after 6 days(2).

### **Bioaccumulative potential**

Based on an estimated bioconcentration factor of 1-6(1), fenuron is not expected to bioaccumulate in fish(SRC).

### **Mobility in soil**

Average Koc values of about 27(1) and 43(2) have been experimentally determined for fenuron. Based on a suggested classification scheme(3), these Koc values indicate that fenuron will have very high soil mobility.

### **Disposal methods**

#### **Product**

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### **Contaminated packaging**

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
