## SECTION 4: First aid measures

### **Description of first aid measures**

#### **If inhaled**

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately.

Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

#### **Following skin contact**

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

#### **Following eye contact**

Rinse with pure water for at least 15 minutes. Consult a doctor.

#### **Following ingestion**

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

### **Indication of any immediate medical attention and special treatment needed**

Immediate first aid: Ensure that adequate decontamination has been carried out. If patient is not breathing, start artificial respiration, preferably with a demand valve resuscitator, bag-valve-mask device, or pocket mask, as trained. Perform CPR if necessary. Immediately flush contaminated eyes with gently flowing water. Do not induce vomiting. If vomiting occurs, lean patient forward or place on the left side (head-down position, if possible) to maintain an open airway and prevent aspiration. Keep patient quiet and maintain normal body temperature. Obtain medical attention. Poisons A and B

## SECTION 6: Accidental release measures

### **Personal precautions, protective equipment and emergency procedures**

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

### **Environmental precautions**

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

### **Methods and materials for containment and cleaning up**

Wear approved respiratory protection, chemically compatible gloves, and protective clothing. Wipe up spillage or collect spillage using a high-efficiency vacuum cleaner. Avoid breathing dust. Place spillage in appropriately labeled container for disposal. Wash spill site.

### **Persistence and degradability**

PURE CULTURE: Iodinated X-ray contrast agents are considered nondegradable by microorganisms(1,2). However when incubated with 1 mM iodipamide at 30 deg C for 32 days, the fungus *Trametes versicolor* has been shown to partially diiodinate C-14 ring-labeled iodipamide but the iodide release was a very small amount of that calculated for complete deiodination(1).

### **Bioaccumulative potential**

An estimated BCF of 10 was calculated in fish for iodipamide(SRC), using an estimated log Kow of 5.16(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC).

### **Mobility in soil**

Using a structure estimation method based on molecular connectivity indices(1), the Koc of iodipamide can be estimated to be  $1.4 \times 10^4$ (SRC). According to a classification scheme(2), this estimated Koc value suggests that iodipamide is expected to be immobile in soil. The estimated pKa of iodipamide is 1.13(3), indicating that this compound will exist almost entirely in the anion form in the environment and anions generally do not adsorb more strongly to soils containing organic carbon and clay than their neutral counterparts(4).

## Disposal methods

### Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
