Personal precautions, protective equipment and emergency procedures

Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

LAURYL ETHANOLAMIDE is a very weak base. Reacts with azo and diazo compounds to generate toxic gases. Flammable gases are formed with strong reducing agents. Reacts with dehydrating agents such as P₂O₅ or SOCl₂. Combustion generates mixed oxides of nitrogen.
