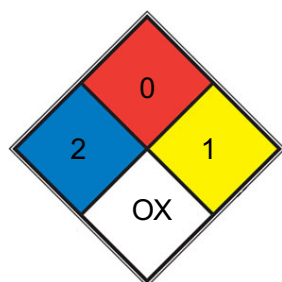

##### Eye/face protection

### Body Protection
