### Description of first aid measures

#### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

#### Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

#### Following eve contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

#### Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

### Indication of any immediate medical attention and special treatment needed

An adult female, with no previous cardiac disease, attempted suicide with a dose of 2400 mg of verapamil, inducing atrioventricular dissociation & circulatory failure. Epinephrine infusion finally restored blood pressure level & allowed a favorable outcome.

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.
